Funding Opportunities

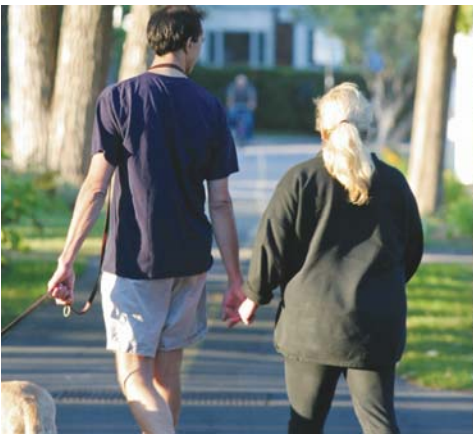
Community Choices funding sources are Individuals, Corporations, Forums and Grants.
